LICENSE FEES

- ❖ Professional Services: \$0.15 per \$100 of Gross Receipts
- ❖ Wholesale: \$0.05 per \$100 of Gross Receipts
- ❖ Carnivals, Circuses, Speedways: \$100 per performance
- ❖ Fortune Tellers, etc: \$1,000.00 per year
- ❖ Massage Parlors: \$5,000 per year
- ❖ Itinerant Merchants or Peddlers: \$100.00 per year
- ❖ Photographers: \$50.00 per year
- ❖ Coliseums, Arenas, etc. with a maximum capacity in excess of 10,000 persons: \$100.00 per year
- ❖ Saving and loan Assoc. and Credit Unions: \$50.00 per year
- ❖ Direct sellers as defined in code of Virginia – over \$4,000 is \$0.08 per \$100.00 in Retail Sales or \$0.05 per \$100.00 in Wholesale sales
- ❖ Heat, Light, Power and Gas: ½ of 1% of Gross Receipts Derived within Town of Edinburg
- ❖ Telephone co.: ½ of 1% of Gross Receipts within Town of Edinburg
- ❖ Retailers, Contractors, Constructing for Sale, Repair, Personal and business as follows:
 - Gross Receipts less than \$15,000 Flat Fee of \$18.00
 - Gross Receipts \$15,001 and over: \$0.13 per \$100 of Gross Receipts
